

RECORD OF ORDINANCES

Ordinance No. 848-14

Passed FEBRUARY 3, 2014

AN ORDINANCE ESTABLISHING RATES FOR ALL USERS OF THE VILLAGE OF TONTOGANY'S ELECTRICAL SYSTEM; REPEALING EXISTING ORDINANCES #797-09, #837-13 AND OTHERS INCONSISTENT HEREWITH; AND DECLARING AN EMERGENCY

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF TONTOGANY, COUNTY OF WOOD, STATE OF OHIO:

SECTION 1: The users of electrical service from the Village of Tontogany shall be subject to the following rates and charges:

RATE PER SERVICE OR DWELLING UNIT PER MONTH OR PART THEREOF

A. RESIDENTIAL SERVICE. Applicable to all residential consumers in a separately metered single-family dwelling unit or multiple dwelling unit for all domestic uses.

B. GENERAL COMMERCIAL SERVICE. Applicable to all electric service provided through a single meter for Commercial type consumers, provided however, service hereunder shall be limited to loads not to exceed 100 kilowatts of average monthly demand.

C. LARGE COMMERCIAL SERVICE. Applicable to all electric service provided through a single meter for Commercial type consumers whose average billing capacity exceeds 100 KVA (Kilo-Volt Amperes).

RECORD OF ORDINANCES

Ordinance No. 848-14

Passed FEBRUARY 3, 2014

SECTION 2. All Energy Charges for consumers outside the Village of Tontogany, Ohio shall be at a rate Twenty-five Percent (25 %) greater than the rate charged to consumers within the Village for the same service.

SECTION 3. All users of the Tontogany Electric System shall be subject to pass-through charges of any Power Cost Adjustment (PCA) charges incurred by the Village from its supplier based upon all KWH used by the consumer.

SECTION 4. TAP FEES.

A. All Residential electric users shall be subject to the following **TAP FEES** when connecting to the village's electric system:

INSIDE CORP.	\$500.00
OUTSIDE CORP.	\$500.00


B. All Commercial electric users shall be subject to **TAP FEES** when connecting to the village's electric system to be determined by the Village's actual cost to connect the user to the village's electric system.

SECTION 5. All users of the Village electric system shall be subject to, and comply with, any and all policies, provisions and conditions as may be adopted by the Village, and may be from time to time amended.

SECTION 6. This ordinance repeals ordinance No. 797-09, No. 837-13 and all others inconsistent herewith.

SECTION 7. The rates and fees herein shall be effective from and after the March 1, 2014 billing of the Village.



This ordinance constitutes an emergency measure necessary for the immediate health, welfare and safety of the citizens of Tontogany due to the requirement to continue to operate and maintain the Village's electrical system at the most reasonable rates, and therefore, shall go into immediate effect upon passage.
