

# RECORD OF ORDINANCES

Ordinance No. 834-12

Passed DECEMBER 3, 2012

**AN ORDINANCE RETAINING THE SERVICES OF THOMAS J. BAMBUROWSKI, ATTORNEY AT LAW, AS VILLAGE LEGAL COUNSEL; AND DECLARING AN EMERGENCY**

**BE IT ORDAINED BY COUNCIL OF THE VILLAGE OF TONTOGANY, COUNTY OF WOOD AND STATE OF OHIO:**

Section 1. That the Village of Tontogany hereby retains the services of Thomas J. Bamburowski, Attorney at Law, 519 West Wooster Street, Bowling Green, Ohio, to serve the Village as its legal counsel, as more specifically enumerated herein for the period January 1, 2012 through December 31, 2013.

Section 2. That the terms and conditions of such services are as follows:

The Village agrees to compensate Thomas J. Bamburowski for legal services the sum of One Hundred Dollars (\$100.00) per hour for all billed hours in 2012 and One Hundred Twenty-five Dollars (\$125.00) per hour for all billed hours in 2013.

All legal services not rendered at council meetings shall be given at the law office of Thomas J. Bamburowski during regular office hours, or at such other times and places as mutually agreed upon. As Village legal counsel, Thomas J. Bamburowski shall have no responsibility for, nor control or direction over, the prosecution of any and all criminal/traffic proceedings involving the Village of Tontogany.

Section 3. That the council hereby finds and determines that all formal actions relative to the adoption of this Ordinance were taken in an open meeting of the Council and that all deliberations of this Council and its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4. That this Ordinance shall be effective for all work performed on and after January 1, 2012.

Section 5. That this Ordinance constitutes an emergency measure necessary for the immediate preservation of the public safety and welfare of the citizens of Tontogany for the reason that time is of the essence to continue the services of a Village Solicitor, and shall, therefore, go into immediate effect upon passage thereof..
