

# RECORD OF ORDINANCES

Ordinance No. 843-13

Passed DECEMBER 2, 2013

AN ORDINANCE ESTABLISHING RATES FOR RESIDENTIAL AND AGRICULTURAL/INDUSTRIAL USERS OF THE VILLAGE OF TONTOGANY'S WATER SYSTEM, REPEALING EXISTING ORDINANCE(S), AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF TONTOGANY, COUNTY OF WOOD, STATE OF OHIO:

**SECTION 1:** The users of water service from the Village of Tontogany shall be subject to the following rates:

**SECTION 2.** All water users shall be subject to the following **TAP**

**FEES** when connecting to the village's water system:

INSIDE CORP.           \$4000.00  
OUTSIDE CORP.       \$8000.00

**SECTION 3.** A **WATER SYSTEM DEVELOPMENT FEE** shall be charged for all new construction as follows:

HOUSEHOLD TAP   \$ 2000.00  
1 1/2 INCH METER \$ 3000.00  
2 INCH METER     \$ 8000.00  
3 INCH METER     \$15000.00  
4 INCH METER     \$25000.00

(ALL OTHER SIZES TO BE DETERMINED ON CASE BY CASE BASIS BY BOARD OF PUBLIC AFFAIRS.)

**SECTION 4.** All users of the Village water system shall be subject to, and comply with, any and all policies, provisions and conditions as may be adopted by the Village, and may from time to time amended.

**SECTION 5.** This ordinance repeals Ordinance Number 800-09 and any and all ordinances inconsistent herewith.

**SECTION 6.** The rates and fees herein shall be effective from and after January 1, 2014.

**SECTION 7.** This ordinance constitutes an emergency measure necessary for the immediate health, welfare and safety of the citizens of Tontogany due to the requirement to continue to operate and maintain the Village's water system since increases have occurred in the charges to the Village by its water supplier, and therefore, shall go into immediate effect upon passage.


