**PERMANENT APPROPRIATIONS**

**ORDINANCE #856-14**

AN ORDINANCE TO MAKE APPROPRIATIONS FOR THE CURRENT EXPENSES AND OTHER EXPENDITURES OF THE VILLAGE OF TONTOGANY, STATE OF OHIO, DURING THE FISCAL YEAR ENDING DECEMBER 31, 2015, AND DECLARING AN EMERGENCY

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF TONTOGANY, STATE OF OHIO:

**Section 1:** That, to provide for the current expenses and other expenditures of the said Village of Tontogany during the fiscal year ending December 31, 2015, the following sums be and they are hereby set aside and appropriated as follows, viz:

**Section 2:** That there be appropriated from the GENERAL FUND:

\$172,593.01

**Section 3:** That there be appropriated from the SPECIAL REVENUE FUND (includes TRANSPORTATION; SPECIAL ASSESSMENT; MOTOR VEHICLE PERMISSIVE TAX):

\$57,340.00

**Section 4:** That there be appropriated from the CAPITAL IMPROVEMENT FUND:

\$10,000.00

**Section 5:** That there be appropriated from the WATER FUND:

\$302,890.00

**Section 6:** That there be appropriated from the ELECTRIC FUND:

\$656,780.00

**Section 7:** That there be appropriated from the OTHER AGENCY -SEWER FUND:

\$80,000.00

**Section 8:** That the Village Fiscal Officer is hereby authorized to draw warrants on the Village Treasury for payments from any of the foregoing appropriations upon receiving proper certificates and vouchers therefore, approved by the board or officers authorized by law to approve the same, or an ordinance or resolution of council to make the expenditures; provided that no warrants shall be drawn or paid for salaries or wages except to persons employed by authority of and in accordance with law or ordinance. Provided further that the appropriations for contingencies can only be expended upon appeal of two-thirds vote of Council for items of expense constituting a legal obligation against the village, and for purposes other than those covered by specific appropriations herein made.

**Section 9:** That this Ordinance be declared an emergency measure to further insure the health, safety and welfare of the residents of the Village of Tontogany, Ohio, and shall become effective upon its passage by Council and approval by the Mayor; or from and after its passage at the earliest period allowed by law.
