AN ORDINANCE ESTABLISHING RATES FOR RESIDENTIAL AND AGRICULTURAL/INDUSTRIAL USERS OF THE VILLAGE OF TONTOGANY'S WATER SYSTEM, REPEALING PRIOR ORDINANCE(S), AND DECLARING AN EMERGENCY.

WHEREAS, the Village of Tontogany is a statutory village located in Wood County, Ohio, and

WHEREAS, the Village of Tontogany has powers of local self-government, including, but not limited to, the power to establish utility and water rates, pursuant to Article XVIII, Sections 3 and 4 of the Ohio Constitution and ORC sections 743.04 and 715.08, and

WHEREAS, expenses related to the maintenance of the water system have increased since rates were last established by the Village Council.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF TONTOGANY, COUNTY OF WOOD, STATE OF OHIO, THAT:

**SECTION 1.** The users of water service from the Village of Tontogany shall be subject to the following rates:

**SECTION 2.** All water users shall be subject to the following **TAP FEES** when connecting to the village's water system:

INSIDE CORP. \$4000.00
OUTSIDE CORP. \$8000.00

**SECTION 3.** A **WATER SYSTEM DEVELOPMENT FEE** shall be charged for all new construction as follows:

HOUSEHOLD TAP	\$ 2000.00
1 1/2 INCH METER	\$ 3000.00
2 INCH METER	\$ 8000.00
3 INCH METER	\$15000.00
4 INCH METER	\$25000.00

(ALL OTHER SIZES TO BE DETERMINED ON CASE BY CASE BASIS)

**SECTION 4.** All users of the Village water system shall be subject to, and comply with, any and all policies, provisions and conditions as may be adopted by the Village, and may from time to time be amended.

**SECTION 5.** This ordinance repeals and any and all ordinances inconsistent herewith.

**SECTION 6.** The rates and fees herein shall be effective from and after July 1, 2018.

**SECTION 7.** This ordinance constitutes an emergency measure necessary for the immediate health, welfare and safety of the citizens of Tontogany due to the requirement to continue to operate and maintain the Village's water system, covering continuing increases in charges to the Village by its water supplier and meeting operating expenses, debt obligations, and capital reserve needs, and therefore, shall go into immediate effect.
