

RESOLUTION 874-16

A RESOLUTION DESCRIBING MUNICIPAL SERVICES APPLICABLE TO THE PROPOSED WOLVERINE AGRICULTURE & INVESTMENTS, LLC ANNEXATION IN COMPLIANCE WITH SECTION 709.03 OF THE OHIO REVISED CODE AND DECLARING AN EMERGENCY

WHEREAS, a petition requesting property annexation has been filed by Gerald Miller, as agent for Wolverine Agriculture & Investments LLC that owns a parcel of land that is part of the Northwest quarter (1/4) of Section Five (5), Town Five (5), Range Ten (10) East in Washington Township, Wood County, Ohio and more specifically described in Exhibit A attached to this resolution.

WHEREAS, pursuant to Section 709.03 of the Ohio Revised Code the Village of Tontogany is required to adopt a statement indicating what services it will provide to the territory proposed, upon its annexation;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF TONTOGANY, WOOD COUNTY, OHIO:

SECTION 1. The Village of Tontogany, Wood County, Ohio hereby states that upon annexation to the Village the following services will be provided to the territory described in the aforementioned petition and otherwise described on Exhibit A:

- (a) Access to water and sewer services provided through Northwest Water and Sewer;
- (b) Access to electric service;
- (c) Street maintenance, street repair and snow plowing services;
- (d) Access to well-trained, fully-equipped and efficient fire department located in the village through Washington Township;
- (e) Access to well-trained, fully-equipped and efficient police through a contract with the Wood County Sheriff's office and the Village of Tontogany; and
- (f) A park system and provides well cared for parks within walking distance of any home within the Village.

SECTION 2. It is found and determined that all formal actions of council concerning or relating to the passage of this Resolution were adopted in an open meeting of council and that all deliberations of this council and any of its committees, that resulted in such formal actions, were in meetings open to the public in compliance with all legal requirements of the Village of Tontogany and the State of Ohio.

SECTION 3. This ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of the citizens of Tontogany, Wood County, Ohio, in order to ensure that the annexation process is able to move forward in a timely manner, and shall be in full force and effect from and immediately after its passage and approval by the Mayor.
