To help you with the water connection for your home, you must have the following completed before the water can be turned on:

- A. Payment of the tap fee, any cost in excess of the tap will be billed to the customer.
- B. Meter bar installed in pit or inside home as deemed correct by the Village of Tontogany. The Village will supply meter, check valve and setting.
- C. If meter installed in home: Install 18-2 wire from meter location to outside of home. Outside portion installed in conduit.
- D. Thermal expansion tank installed on hot water heater.
- E. Adjustable Pressure reducing valve.
- F. Final inspection of the above.

Water line specifications:

Type (K) copper or 200 psi plastic pipe (SDR-9). If plastic pipe is used, a No 12 gauge tracer wire must be installed with it and buried to a depth of 48 inches.

The Village of Tontogany accepts the responsibility to provide the customer with water at the customer's property line nearest to our existing water main to the best of our ability. The customer agrees to the following:

- A. Pay the standard hook up fee for new construction with application (unless other arrangements are made prior to hook up) and system development fee (if applicable).
 - 1. Inside corporation limits: \$4000.00 If a second ³/₄" tap is requested for sprinkler systems - \$250.00
 - 2. Outside corporation limits: \$8000.00 with application & signed annexation agreement, any cost in excess of tap fee when billed by THE TONTOGANY UTILITIES DEPARTMENT.
- B. Pay for water energy consumed at meter based on the following procedures
 - 1. Meter will be read at the end of the month and a bill will be sent to the customer.
 - 2. Customer will pay the total amount due on or before the twentieth of the month billed.
 - 3. If the amount due is not received on or before the twentieth of the month billed, a 10% late penalty will be added to the account. Failure to receive bill does not waive penalties.
 - 4. We review our utility accounts quarterly. Any accounts that are not current will have their balances certified to the county auditor and the amount past due will appear on their tax duplicates. If the bill is certified, a \$50.00 certification fee will be added to the account. You will be notified 10 days prior to the certification of your water bill.
 - 5. In the event that a check comes back to us as un-payable, your account will be charged a \$30.00 bad check fee. You will be sent a notification letter and the amount of the bad check will be placed back on your account and will show up on your bill.
