

ORDINANCE NO. 905-19

VILLAGE OF TONTOGANY
WOOD COUNTY, OHIO

ORDINANCE ESTABLISHING NEW WATER RATES

WHEREAS, the Village of Tontogany is a statutory village located in Wood County, Ohio, and

WHEREAS, the Village of Tontogany has powers of local self-government pursuant to Ohio Constitution Article XVIII, Section 3, and the Ohio Revised Code, including the power to establish rates for water and sewer usage, and

WHEREAS, the Council of the Village of Tontogany adopted Ordinance Number 887-18 establishing rates for residential and agricultural/industrial users of the Village water system, and

WHEREAS, the costs of maintaining the Village water system infrastructure, the costs of water purchased from the Village's source, and the costs to service water-related debt require the Village to increase the rates charged to users of the Village water system.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the Village of Tontogany, Wood County, Ohio, that:

Section 1: The users of water service from the Village of Tontogany shall be subject to the following rates:

RATE PER SERVICE OR DWELLING UNIT PER MONTH OR PART THEREOF

RESIDENTIAL SERVICE

Inside Rate

Minimum Charge (First 2,000 gal. or part thereof)	\$28.18
Greater than 2,000 gallons (per 1,000 gal. or part thereof)	\$14.12

Outside Rate

Minimum Charge (First 2,000 gal. or part thereof)	\$42.27
Greater than 2,000 gallons (per 1,000 gal. or part thereof)	\$21.19

AGRICULTURAL/INDUSTRIAL SERVICE

Minimum Charge (First 6,000 gal. or part thereof)	\$10.99
Greater than 6,000 gallons (per 1,000 gal. or part thereof)	\$20.76

Section 2: All users of the Village water system shall be subject to the following tap fees when connecting to the Village water system:

Inside Village:	\$10,000.00
Outside Village:	\$10,000.00

Section 3: A water system development fee shall be charged for all new construction, as follows:

Household Tap:	\$2,500.00
1 ½ in. meter:	\$3,750.00
2 in. meter:	\$10,000.00
3 in. meter:	\$18,750.00
4 in. meter:	\$31,250.00
Other:	As determined by Council at time of application

Section 4: A monthly line maintenance fee shall be charged for meter sizes, as follows:

Household:	\$15.00
1 in. meter:	\$45.00
1 ½ in. meter:	\$97.50
2 in. meter:	\$195.00
4 in. meter:	\$397.50
6 in. meter:	\$600.00

Section 5: In the event a capacity surcharge is assessed by the water supplier, such surcharge shall be paid by the Village water customer, in addition to any other fee assessed herein.

Section 6: All users of the Village water system shall be subject to, and shall comply with, any and all policies, provisions, and conditions in effect at the time of this Ordinance or as subsequently adopted or imposed.

Section 7: All ordinances, policies, provisions, and conditions not amended hereby, or inconsistent with this ordinance, are hereby repealed.

Section 8: This Ordinance, and the rates established hereby, shall become effective the earlier of thirty days from passage or December 1, 2019.

Section 9: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any other committees that results in such formal action were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Revised Code of Ohio.
