

ORDINANCE NO. 921-20

CONFIRMING, RATIFYING AND AUTHORIZING THE EXPENDITURE OF THE VILLAGE'S SHARE OF CORONAVIRUS RELIEF FUNDS, AND DECLARING AN EMERGENCY.

WHEREAS, the Village previously passed Resolution No. 915-20 requesting its share of funds from the County Coronavirus Relief Distribution Fund; and

WHEREAS, the Village established in Resolution No. 915-20 that funds received from the County Coronavirus Relief Distribution Fund would be expended only to cover COVID related costs; and

WHEREAS, the Ohio Office of Budget & Management has recommended passage of legislation for COVID related expenditures as additional documentary support of its expenditures;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF TONTOGANY, OHIO, THAT:

SECTION 1. This Ordinance is Council's documentary support confirming and ratifying certain expenses of \$0.00 through 9/30/2020 for Covid-19 illness, absence, exposure or symptoms in compliance with Village, County, Federal or State of Ohio directives, regulations, guidelines or policies, and State Auditor guidance or Village legal opinion, paid from the Village's Coronavirus Relief Fund.

SECTION 2. This Ordinance is Council's documentary support confirming and ratifying the Covid-19 supply and service expenses of \$699.85 as approved by Council.

SECTION 3. This Ordinance is Council's documentary support confirming and ratifying prior Covid-19 supply and service expenses as previously purchased and authorized by the Mayor, department heads or the Fiscal Officer and/or Treasurer in the amount of \$699.85, plus additional outstanding encumbrances of \$0.00 as of 9/30/20.

SECTION 4. The Mayor or Council is hereby authorized to approve additional expenses from the Coronavirus Relief Fund available balances, on an on-going as needed basis, through 12/31/2020.

SECTION 5. This is an emergency measure necessary for the immediate preservation of the health, safety and welfare of the Village and its residents for the reason that State and Federal regulations for the receipt and expenditure of Coronavirus Relief Funds requires the Village to timely report expenditures and return unused funds.

SECTION 6. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions, were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Revised Code of Ohio.
