ORDINANCE NO. 939-21

VILLAGE OF TONTOGANY WOOD COUNTY, OHIO

ORDINANCE ESTABLISHING INCREASED ELECTRICITY RATES AND TAP FEES, AND DECLARING AN EMERGENCY

WHEREAS, the Village of Tontogany is a statutory village located in Wood County, Ohio, and

WHEREAS, the Village of Tontogany has powers of local self-government pursuant to Ohio Constitution Article XVIII, Section 3, and the Ohio Revised Code, including the power to establish rates for utility usage, and

WHEREAS, Village of Tontogany provides electric service to the residential and users commercial located within and outside the Village, and

WHEREAS, the Council of the Village of Tontogany adopted Ordinance Number 848-14 establishing rates and rate increases for residential and commercial users of the Village electric service, and

WHEREAS, the costs of providing electricity to customers and of maintaining the Village electric service infrastructure require the Village to increase the rates charged to users of the Village electric system.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the Village of Tontogany, Wood County, Ohio, that:

Section 1: The users of electric service from the Village of Tontogany shall be subject to the following rates:

- All users of the Tontogany Electric System shall be subject to pass-through charges of any Power Cost Adjustment (PCA) charges incurred by the Village from its supplier based upon all KWH used by the consumer.
- Section 3: All Residential electric users shall be subject to the following Tap Fee when connecting to the Village's electric system:

Within the Village:	\$ 4,000.00
Outside the Village:	\$ 4,000.00

Any cost incurred by the Village in excess of the established Tap Fee which is related to establishing an electric service connection shall be borne by the customer.

- All users of the Village electric system shall be subject to, and shall comply with, any and all policies, provisions, and conditions in effect at the time of this Ordinance or as subsequently adopted or imposed.
- <u>Section 5:</u> Provisions of ordinances, policies, conditions and rates inconsistent with this rate Ordinance are hereby repealed.
- Section 6: This Ordinance repeals Ordinance 848-14, and the rates established hereby shall be effective immediately after passage.
- Section 7: The Village Fiscal Officer is hereby directed to publish this Ordinance in accordance with law.
- Section 8: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any other

committees that results in such formal action were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Revised Code of Ohio.

This measure is an emergency measure necessary for the immediate preservation of the health, safety and welfare of the Village and its residents for the reason that after a series of supplier rate increases without corresponding Village rate increases there has been created financial deficiencies in the operation of the Village's Electric Service System which must be addressed immediately to insure satisfactory electric service to Village residents, both residential and commercial.
