ORDINANCE NO. 943-21

**AN ORDINANCE TO MAKE PERMANENT APPROPRIATIONS
FOR THE CURRENT EXPENSES AND OTHER EXPENDITURES OF
THE VILLAGE OF TONTOGANY, COUNTY OF WOOD, AND STATE OF
OHIO, DURING THE FISCAL YEAR ENDING DECEMBER 31, 2022,
AND DECLARING AN EMERGENCY**

BE IT ORDAINED by the Council of the Village of Tontogany, County of Wood, State of Ohio, that:

Section 1: To provide for the current expenses and other expenditures of the said Village of Tontogany during the fiscal year ending December 31, 2022, the following sums be and they are hereby set aside and appropriated as follows, viz:

Section 2: That there be appropriated from the GENERAL FUND:

\$275,825.00

Section 3: That there be appropriated from SPECIAL REVENUE FUNDS (including \$54,000.00 from STREET MAINTENANCE; \$12,895.00 from MOTOR VEHICLE PERMISSIVE TAX; \$20,007.45 from AMERICAN RESCUE ACT FUND; \$11,000.00 from SPECIAL ASSESSMENT - STREET LIGHTS; and \$20,000.00 from SPECIAL ASSESSMENT - TREES), a total of:

\$117,902.45

Section 4: That there be appropriated from the CAPITAL IMPROVEMENT FUND:

\$1,594.48

Section 5: That there be appropriated from the WATER FUND:

\$328,605.00

Section 6: That there be appropriated from the ELECTRIC FUND:

\$637,490.00

Section 7: That there be appropriated from the OTHER AGENCY - SEWER FUND:

\$120,000.00

Section 8: That the Village Fiscal Officer is hereby authorized to draw warrants on the Village Treasury for payments from any of the foregoing appropriations upon receiving proper certificates and vouchers therefore, approved by the board or officers authorized by law to approve the same, or an ordinance or resolution of Council to make the expenditures; provided that no warrants shall be drawn or paid for salaries or wages except to persons employed by authority of and in accordance with law or ordinance; provided further that the appropriations for contingencies can only be expended upon appeal by two-thirds vote of Council for items of expense constituting a legal obligation against the Village, and for purposes other than those covered by the other specific appropriations herein made.

Section 9: That this Ordinance is hereby declared to be an emergency measure for the immediate preservation of the public health, safety and welfare of the Village and its residents, for the reason that the accounts of the above funds must have sufficient balances for the proper expenditure procedures to be filed in 2022, and shall become effective upon its passage by Council and approval by the Mayor; or from and after its passage at the earliest period allowed by law.

Section 10: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any other committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.


CERTIFICATION
