

VILLAGE OF TONTOGANY, WOOD COUNTY, OHIO  
RESOLUTION NO. 979-24

**A RESOLUTION ADOPTING THE WOOD COUNTY HAZARD MITIGATION PLAN, AND  
DECLARING AN EMERGENCY**

**WHEREAS**, the Village of Tontogany is an Ohio statutory municipality with powers of local self-government pursuant to Ohio Constitution Article XVIII, Sections 3 and 7, and

**WHEREAS**, the Wood County Emergency Management Agency helped develop a multi-hazard mitigation plan, known as the Wood County Hazard Mitigation Plan of 2024, (the Plan), in accordance with the Disaster Mitigation Act of 2000, and

**WHEREAS**, the Wood County Emergency Management Agency submitted the Plan to the Ohio Emergency Management Agency (OEMA) and the Federal Emergency Management Agency (FEMA), and the Plan has been formally approved by both agencies, and

**WHEREAS**, the Board of County Commissioners of Wood County, Ohio, by Resolution No. 24-00432, has adopted the Plan

**WHEREAS**, the Village of Tontogany passed Resolution 973-24 “approving” the Plan, and

**WHEREAS**, the Wood County Emergency Management Agency prefers the Village “adopt” the plan, rather than “approve” it.

**NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE OF TONTOGANY, OHIO,**

**Section 1.** That the Council of the Village of Tontogany hereby adopts the Wood County Hazard Mitigation Plan, and authorizes the Mayor to execute any documents necessary to the implementation of the Plan.

**Section 2.** That the Village of Tontogany Fiscal Officer is directed to deliver a copy of this Resolution to the Wood County Emergency Management Agency, attn: Mr Jeff Klein, Director, One Courthouse Square, Bowling Green, Ohio 43402.

**Section 3.** This measure is an emergency measure, necessary to the immediate preservation of the health, safety and welfare of the Village and its residents for the reason that the Wood County Emergency Management Agency has rejected the previously approved resolution and requires adoption forthwith.


